- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis for Qualification

Accounting Statement

In my opinion, the Accounting Statement has not been prepared in accordance with proper practice and does not properly present the Council's receipts and payments and financial position.

• The Council excludes from its accounts payments that have been issued during the year but presented to the bank. This overstates the year end financial position and misstates the payments made in each year.
