In 2024-25, the Council made payments totalling £_____ Nil _____ under section 137. These payments are included within 'Other payments' in the Accounting Statement.

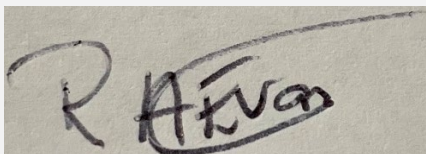
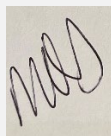

Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2025 of **Llantysilio Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council:

AGS 3: We have ensured that we electronically publish the information the Council is required to publish by law, on its website at www.llantysiliocc.co.uk – Notice of completion of audit

As per Line 3 of the AGS, the Council has stated that they electronically publish the information the Council is required to publish by law, on its website.

The Council does not publish on its website the information it is required to publish electronically by section 55 of the Democracy and Boundary Commission Cymru etc. Act 2013, the Local Government and Elections (Wales) Act 2021 and the Local Government Act 2000. This is with regards to the 2023-24 Notice of completion of audit.

AGS 2: No Training Plan

I draw attention to the negative response in the Annual Governance Statement regarding the Council adopting a Code of Conduct and Training Plan. The Annual Governance Statement sets out the minimum governance standards that the Council should comply with.

I note that the Council has not met its obligation under the Local Government and Elections (Wales) Act 2021 to create and publish a training plan.

We recommend that the Council creates a training plan to ensure that all members understand and are properly equipped to fulfil their role. As of 2025-26 the Council have adopted an appropriate Training Plan.

There are no further matters I wish to draw to the Council's attention.
