<u>Minute No. 19/3616 – Community Problems.</u> The Clerk said that she has contacted all the relevant departments regarding the issues brought up under this item on the Agenda.

Cllr. Picket said that he was disappointed that the matter of the roadside gorse has still not been attended to. He said that he would contact Countryside Services again and stress the urgency of cutting back the gorse before the onset of summer.

19/3628 AFFORDABLE HOUSING

Still awaiting an update from Pentredŵr Community Association.

19/3629 DEFIBRILLATOR

Cllr. Mrs Smith proposed that the Council purchase a defibrillator through the Welsh Ambulance Service who offer the best deal and free training.

The costings are as follow: -

Zoll Aed Plus £800.00 + vat.

Free Pads and Batteries from Welsh Ambulance Service.

Heated lockable cabinet £340.00 + vat.

Electrical installation cost between £90.00 to £190.00.

Free training CPR use AED from Welsh Ambulance Service.

It was noted that any VAT paid would be refundable and the services of a qualified electrician might also be provided cost free.

The Clerk said that she had contacted the Chairman of the Friends of Llangollen Health Centre and it looks hopeful that they would provide match funding towards this project.

Resolved: that the Clerk purchase a defibrillator from the Welsh Ambulance Service and that the Council decides on where to site it at a later date.

The Clerk to investigate match funding from the Friends of Llangollen Hospital.

19/3630 **CEMETERY**

a) <u>Test holes</u>

Concern was expressed that the holes had not been taken down to 6m, as legally required for burials. The Chairman said he would speak to the contractor to clarify the situation.
